**CALL TO ORDER:** Chairman Alan Dustin called the meeting to order at 6:00 p.m.

**ACTION ITEMS:** Payroll and Bill manifests signed; tax abatement for Chase signed, nominee form for Mitchell Harrison to be reappointed to Local River Management Advisory Committee signed; Police grant agreement signed, read mail

**DISCUSSION:** Prescott presented a purchase order for approval for 10 culverts in the amount of \$2590. He said the money would come from the special highway block grant. After some discussion, both Alan and Mary Ann signed the PO.

Prescott gave an update on the Dodge. He said that while they had the clutch pulled out, they noticed the oil pan was no good. This is under warranty and will have to schedule to get it to Dodge Chrysler to replace it.

Prescott indicated that he was planning on getting the glass from the recycling center before the end of the year to put on Homestead Road.

Discussion took place on whether the LED lights that we received some grant funds for the highway department had to wait until next year since we still had money in the building and maintenance line. Charlotte will look into this and Prescott will see if Jack is able to do it this year and if there is any change in cost.

Discussion took place about what the right of way is for town roads. Prescott was not able to find anything in the records that stated what this is and that we would need to write a warrant article and have it voted on.

Prescott said that they were able to drain the water from the beaver dam but that the beavers have already started rebuilding. He indicated that the owners were not happy that all the water was drained and have rescinded their permission for any further involvement with maintaining the dam. He thought that we should reach out to legal to see if owners are responsible if any damages occur to town property due to the beaver dam. The Board Agreed with this.
