CALL TO ORDER: Mr. McCarty called the Select Board meeting to order at 5:02 PM and then proceeded with leading the agenda-based discussion.

DEPARTMENT REPORTS:

Fire Department – No updates.

Highway – Mr. Trafton reports that they have received the tire changer, but are still waiting for the balancer.

Police Department – Chief Murrell brings up the recent Keene Sentinel article about regional call volumes taken by the State Police. Accompanying the article is a bar graph that displays the number of calls taken by the State Police per town, with Alstead showing 201 calls. He provides important clarification about this data. It represents all calls that come into the State Police, including ambulance calls, and calls redirected to Alstead's Police Department during times we're on duty. It also includes all motor vehicle stops by State Police in Alstead. As a result, the numbers are inflated.

Town Office Administrator – Mrs. Gratacos reports that the System for Awards Management (SAM) renewal is in process. She also reports that tax forms were received today and will be sent out soon. The deadline for property taxes is 1/20/25.

BOARD REPORTS:

Mr. Kemp – He has been talking with a Wilmington Trust representative about the Vilas Trust being significantly lower for 2024. He has another call scheduled with her on 1/9 and asks the

Board if it's ok to discuss changing the payment schedule to move payments earlier in the year (versus January). There is no opposition from Mr. McCarty or Mr. Saxton. Mr. McCarty is also interested in whether the checks received are for the prior Fiscal Year. If so, he suggests having them changed to the same Fiscal Year instead.

Mr. Kemp has also requested to discuss suggestions for the yearly Selectman's report dedication in non-public session after tonight's meeting, and would like to suggest including the ice skating rink in the report.

Mr. McCarty – The 1/16 Public Hearing regarding Walpole withdrawing from the Fall Mountain Regional School District has been cancelled due to scheduling conflicts. Mr. McCarty is working on rescheduling that and hopes to have it before the Deliberative Session.

He is also putting together a postcard to be sent to residents with these dates.

Mr. Saxton – He completed the cost per warrant article and sent that to Mr. Kemp. Mr. Kemp updated the warrant article draft to include these figures.

PUBLIC COMMENTS/QUESTIONS: Mr. Nalevanko asks how residents have responded so far to termination of plastics recycling. There was a small group of upset residents and one resident who exhibited particularly aggressive behavior toward Transfer Center staff. As a result, Mr. Kemp spent the day at the Transfer Station on Saturday to allow residents an opportunity to stop and discuss their questions and concerns with him. Mr. McCarty was also at the Transfer Station for a portion of the day. Corporal Underwood was also there to provide support to Mr. Kemp, Mr. McCarty, and the Transfer Center staff. Only one person stopped to discuss it with Mr. Kemp. Mr. Nalevanko also asked about the Town's ability to ban residents from going to Town property due to their behavior. Chief Murrell confirms that the Town can "no trespass" a resident from Town property if a resident is particularly aggressive or threatening.

This can temporarily be done without Selectman approval via emergency order of the police, if necessary, but ultimately it must be voted on by the Selectman (even the emergency orders). Chief Murrell and the Selectman note that this is not something they take lightly, but it is something they're prepared to do and can be done on a temporary or permanent basis.
