CALL TO ORDER: Mr. McCarty called the Select Board meeting to order at 10:00 AM and then proceeded with leading the agenda-based discussion.

- K. Ambulance Revolving Fund Mr. Kemp reports that he made the journal entry in QuickBooks to show that we took \$50,000 of the revenue and moved it to the Ambulance Revolving Fund. The other half of that journal entry is that \$50,000 of that revenue gets used and pays \$50,000 worth of the Wage Line in the Ambulance. Moving forward the money will actually be put in the Ambulance Revolving Fund as reimbursement. Mr. McCarty reports that he has asked Mr. Waldmann for monthly reports on this fund. Regarding the recording of funds in two different systems (since Mr. Waldmann does not use QuickBooks), Mr. Kemp notes that since Payroll is recorded in QuickBooks, unless the Ambulance starts to make significantly more money than that, this will account for the majority of the funds to be recorded.

L. Department & Board

NEW BUSINESS: Mr. Saxton reports that he spoke with a resident (who wishes to remain anonymous) who has offered to make a financial donation to the repairs of the ambulance. He instructed him to write a check to the Town of Alstead, with a memo to the Ambulance Fund and drop it off with the Town Clerk. Mr. Kemp reports that he came across information on the New Hampshire Municipal Association (NMHA) site talking about how municipalities are not able to receive payments directly from private citizens and have them added to the General Fund. The process that they laid out for situations like this is to set up a trust fund and add the money to that. Mr. McCarty says he believes we can have a Public Hearing for any donation made over a certain amount, and let the taxpayers in attendance decide. Mr. Kemp says this is also part of the process laid out by NMHA. Mr. McCarty will seek the advice of legal counsel to see how best to proceed.

OTHER ITEMS: The list of Warrant Articles on the whiteboard was reviewed and discussed. Mr. Saxton made a motion to not proceed with the procurement via Warrant Articles of a ballot tabulation machine, which was passed by the Board.
